## 9. Vendor Advisory Committee - Mitzi Villalon

**A.** VAC did not meet this month in the traditional sense, instead, we held our 28<sup>th</sup> Annual KRC Vendor Advisory Luncheon last Friday. There were 302 individuals in attendance with 21 vendor booths. I unfortunately, could not attend the luncheon but have received several comments that the speaker was extremely engaging and everyone had a good time. Would anyone like to elaborate on the event?

## 10. Staff Report - Cherylle Mallinson

#### a. Self Determination

- **a.** On October 1, 2018, the Department selected 2,500 individuals to participate in the Self-Determination Program (SDP.) Since then, of the 2,500 individuals initially selected, more than 450 have informed their regional center that at this time, they do not wish to participate in SDP. Therefore, on November 22, 2019, the Department will select additional individuals for the SDP. To be considered for selection, the names of individuals who have attended an SDP informational meeting must be submitted to the Department by November 15, 2019. KRC will be sending the list as early as tomorrow
- **b.** The November 22, 2019 selection will be prioritized on the following:
  - The total number of participants at each regional center is consistent with the relative percentage of total consumers served by all regional centers
  - Individuals who are age 42 years and older
  - Siblings of individuals who previously selected for SDP

- Members of SDP local volunteer advisory committees (as of October 8, 2019) of their family members
- Maintain as close as possible the relative ethnic diversity within each regional center catchment area
