Updates on SDP at KRC and statewide

Discussion

a. Celebrations (Kulzer-Reyes)

Kelly shared that she did not have celebrations today so she invited the group to share their celebrations instead. Sandra mentioned that she was grateful for improved communication between families and KRC staff.

b. Obstacles (Kulzer-Reyes)

Kelly mentioned she's concerned about the time frames for budgets spending plans and communication between KRC and families. Dustin shared that she is having similar concerns and offered the idea that perhaps we should clean up the procedures prior to trying to enroll more individuals in the self determination program at KRC.

Update on the DDS SDP workgroup meeting

Rick and Kelly mentioned at the most recent DDS SDP work group meeting there was discussion of standardizing how independent facilitators are certified. Kelly also mentioned that she shared with DDS that this is unlikely to be successful as independent facilitators like her would work around that certification process. Independent facilitators should be seen as partners instead of trying to create a system to solve a specific problem if DDS is having specific problems with independent facilitators those need to be addressed at the individual level instead of at a system wide level otherwise the autonomy and independence that the self determination program is supposed to provide will simply be erased.

Participant choice specialist, Chloe Hayes, gave updates on the data for KRC clients moving into the self determination program. Rick and Kelly both mentioned concerns about how successfully we are moving people into self determination.
