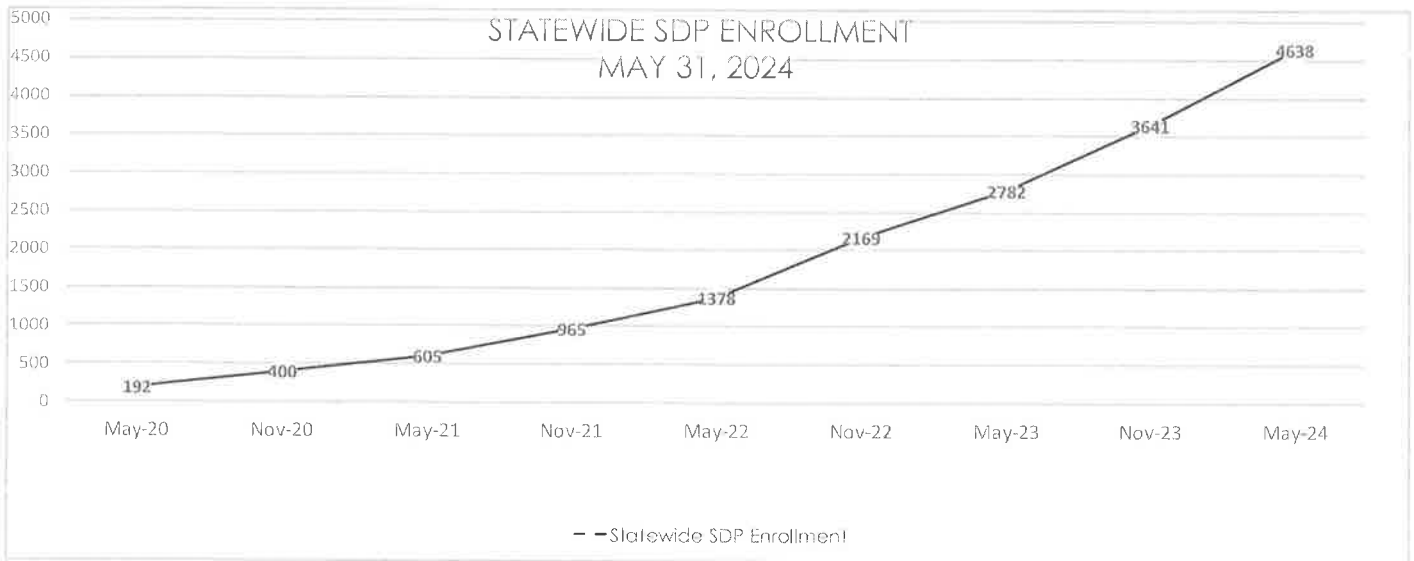

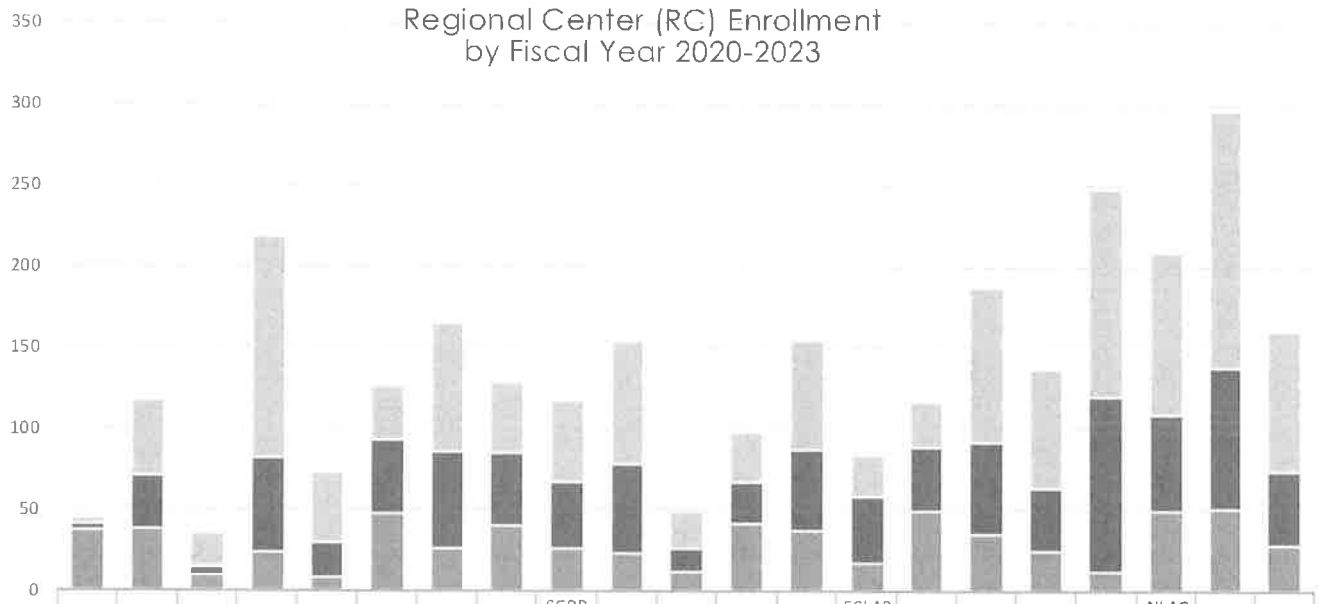

by Fiscal Year 2020-2023

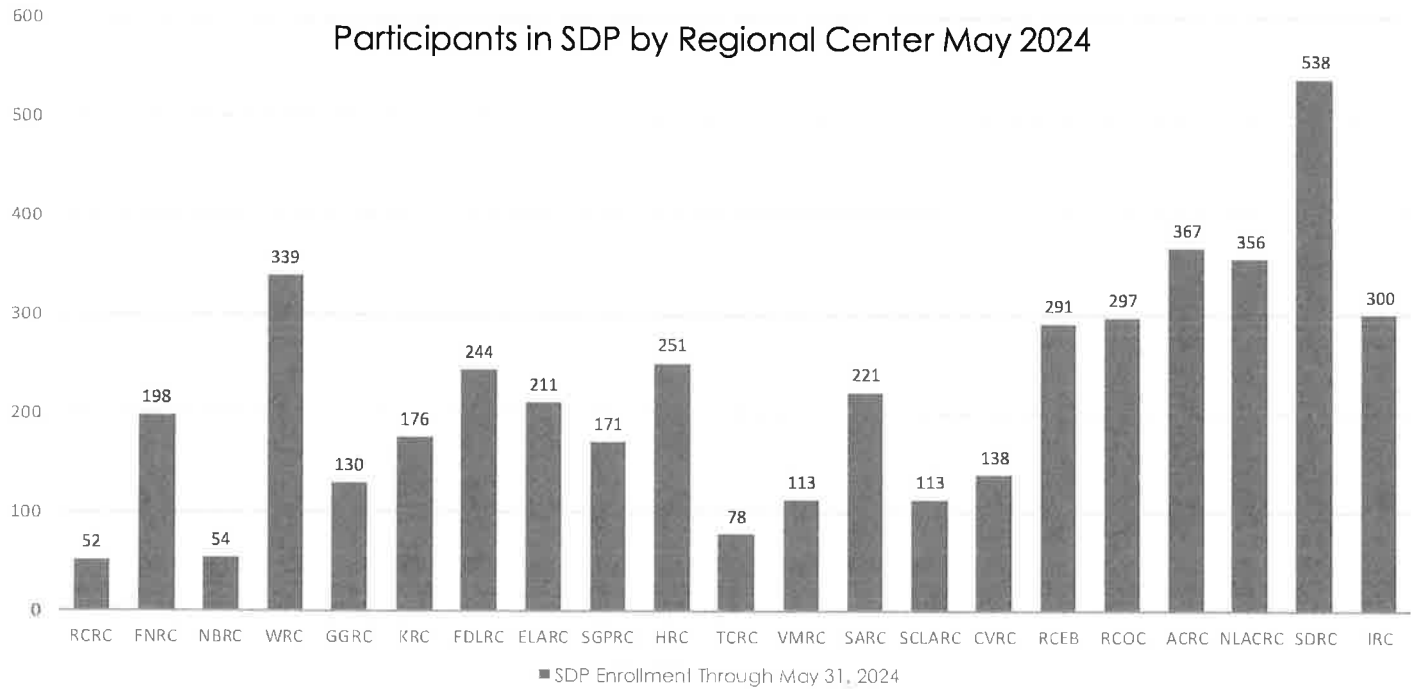

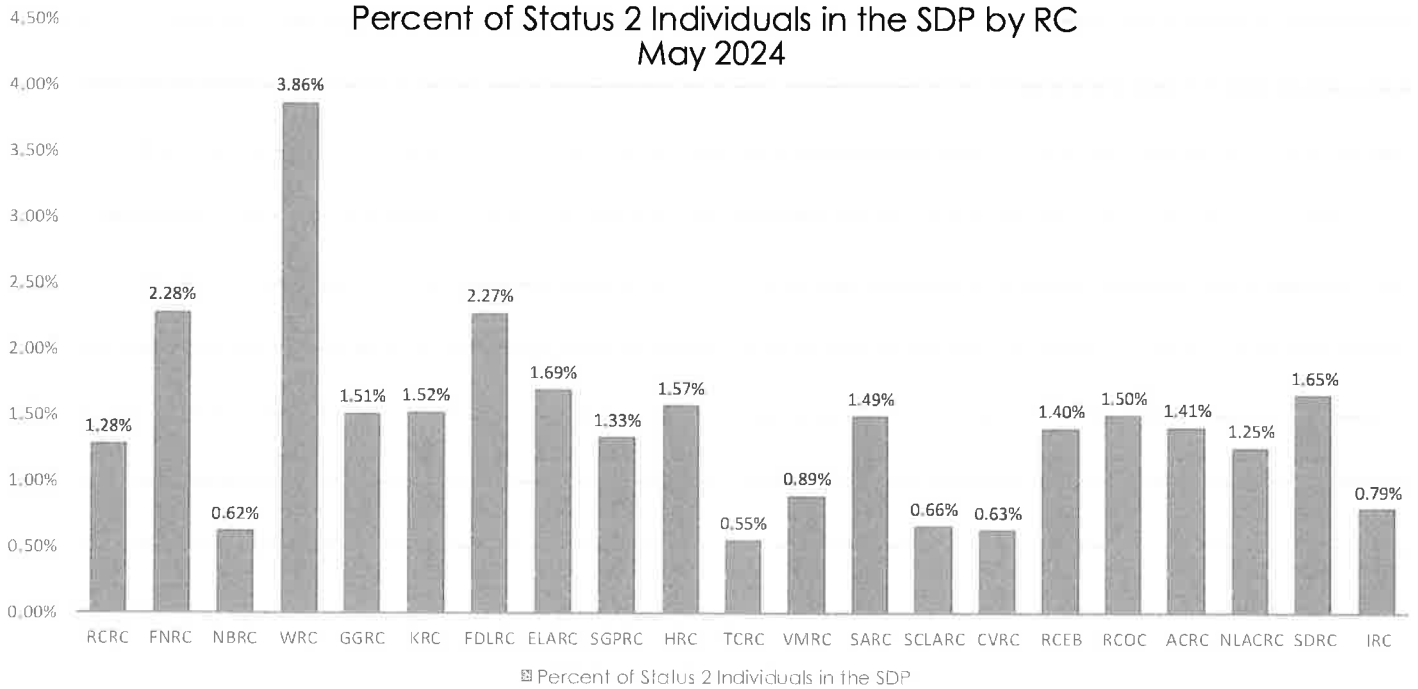

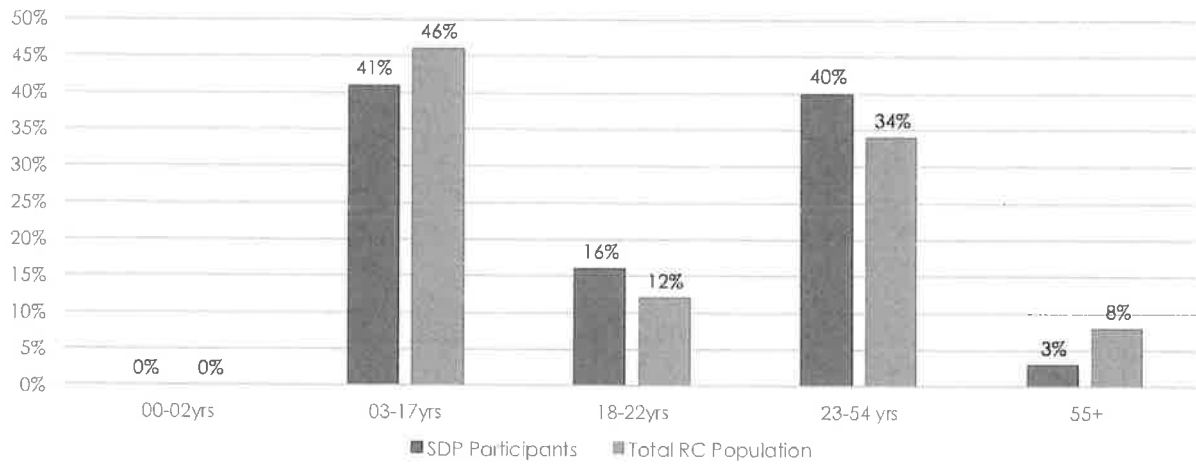

May 2024



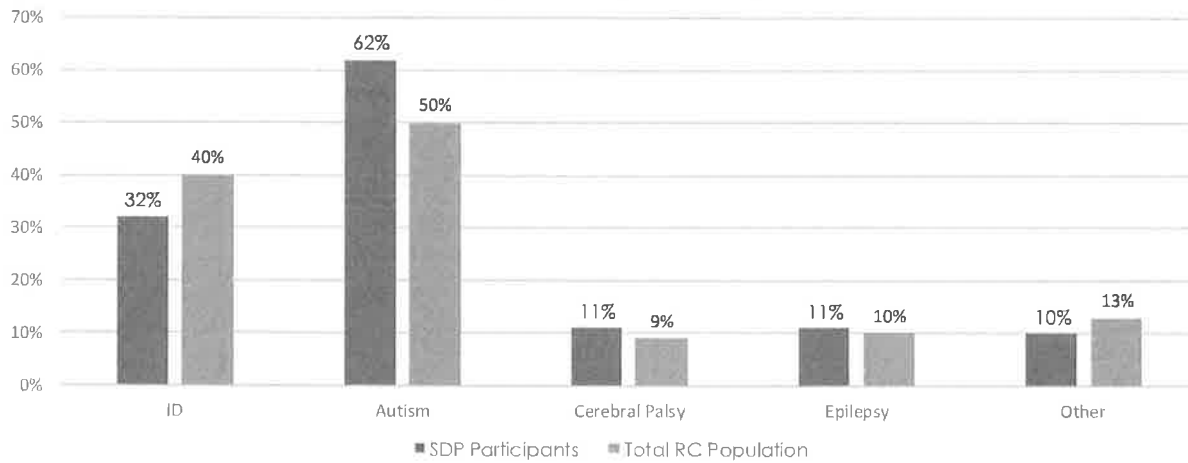
SDP Participants by Age

May 2024, By Age



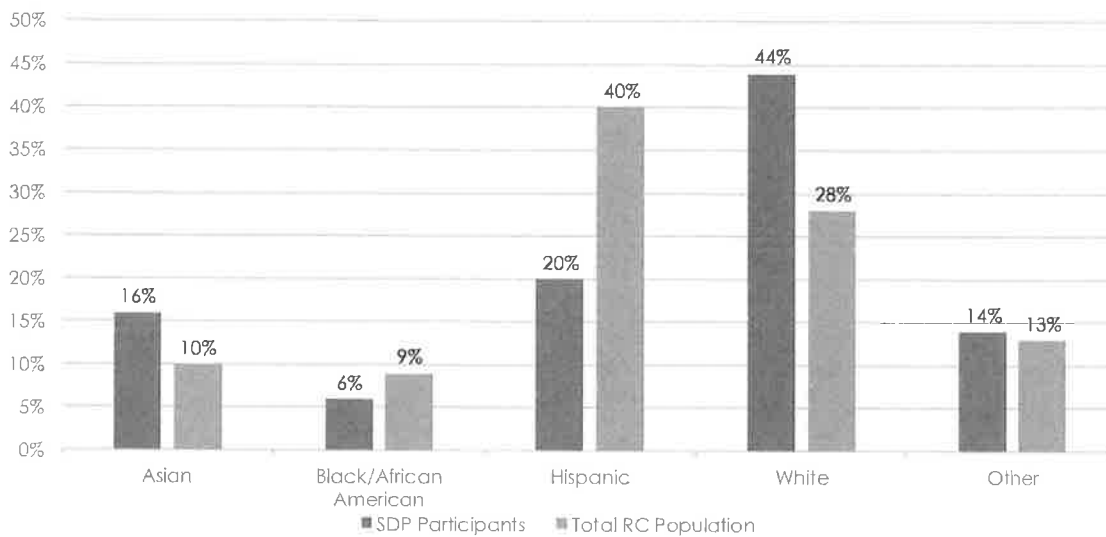
SDP Participants by Type of Disability

May 2024, By Disability



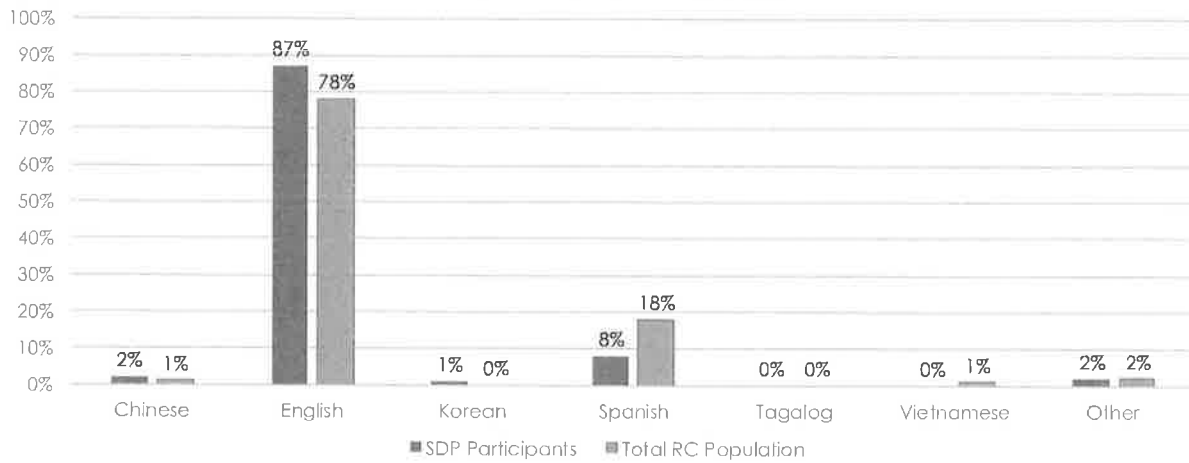
SDP Participants by Ethnicity

May 2024, By Ethnicity



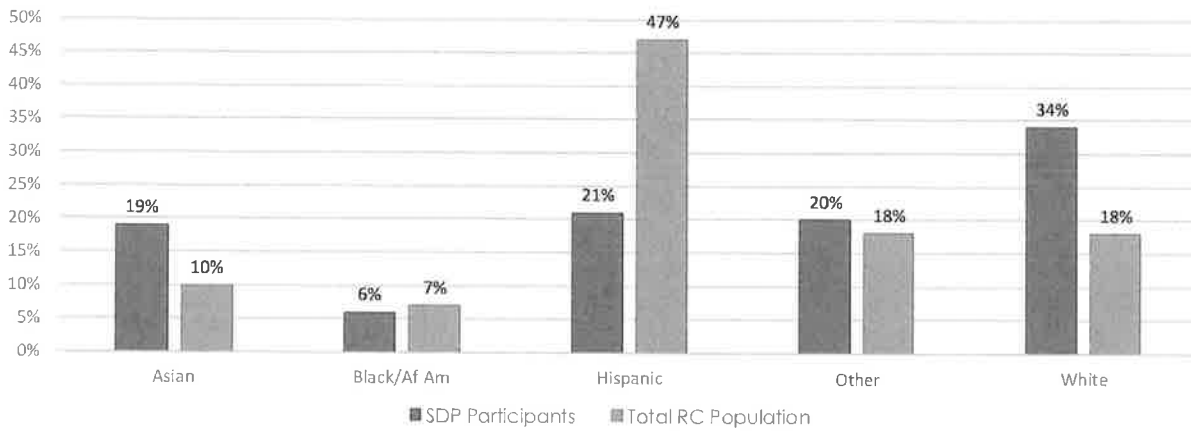

May 2024, By Language



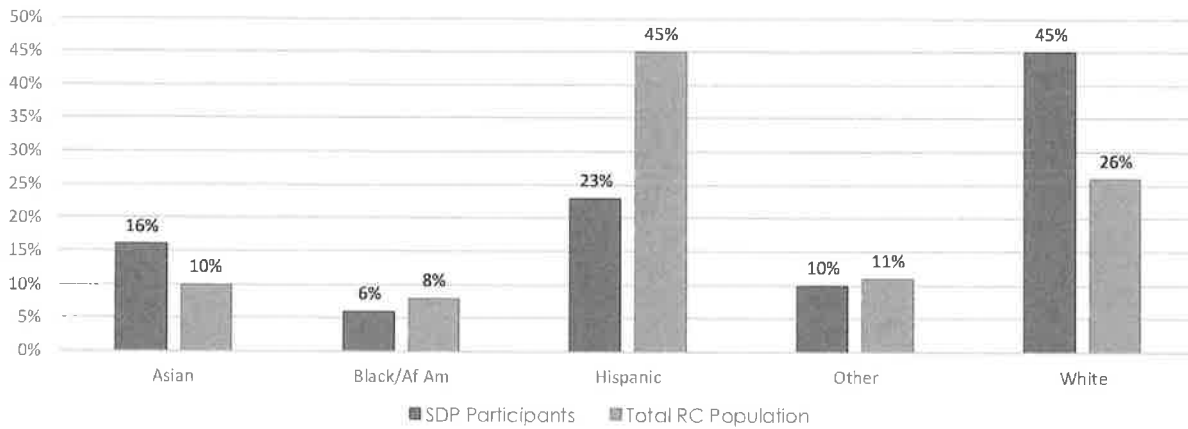
SDP Participants by Age & Ethnicity (Age 03-17)

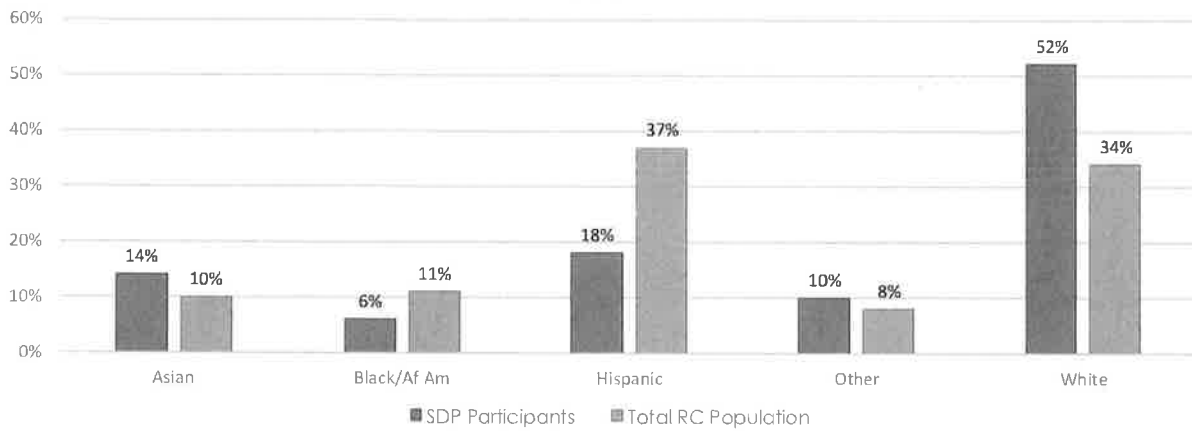
SDP Participants by Age & Ethnicity (Age 18-22)

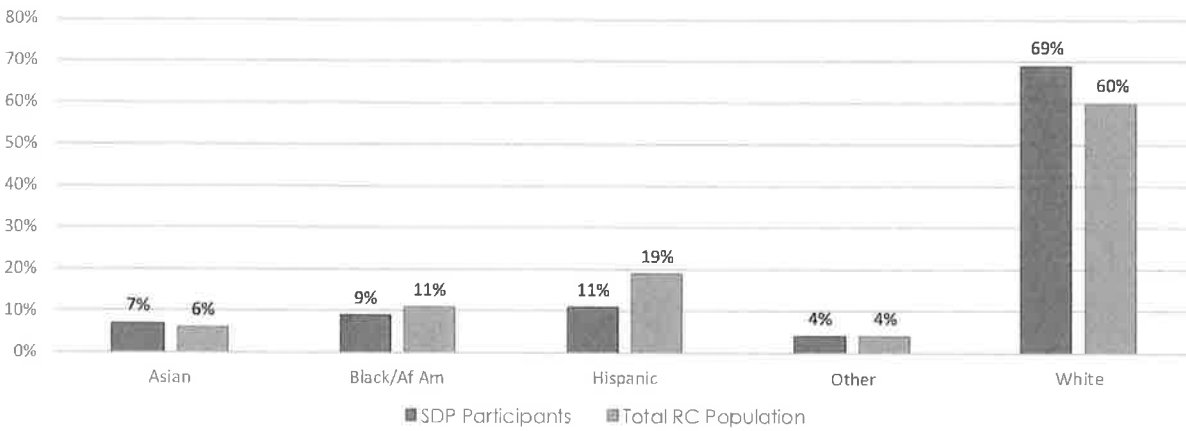
SDP Participants by Age & Ethnicity (Age 23-54)

April 2024: Billing Requirements for Other Rates



The Department released a correspondence to regional centers regarding clarification on the updated billing requirements for services as described in the [December 26, 2023](#), directive. This correspondence replaces the requirements identified in the previous directive for SDP Providers billing other than an hourly or daily rate.

April 2024: Employer Burden and Other Employment-Related Costs



The Department released guidance regarding employer burden costs and other employment-related costs subjected to participants of Self-Determination Program (SDP) and the Financial Management Services (FMS).

April 2024: FMS Provider Requirements



The Department released guidance to regional centers and Financial Management Services (FMS) regarding an update to the FMS provider requirements as outlined in the correspondence dated [December 21, 2018](#)

The Department released correspondence to regional centers to provide guidance on the implementation of 2021 Trailer Bill Language, which included requirements for the annual confirmation of the composition of the regional center's Self-Determination Program(SDP) Local Volunteer Advisory committee.

Recent DDS Directives



July 2024: Initial Person-Centered Plan and Pre-Enrollment Transition Supports Guidance

The Department released correspondence to regional centers updating the guidance regarding the initial person-centered plan and pre-enrollment transition supports to potential Self-Determination Program (SDP) participants. This guidance replaces the [December 22, 2023](#) guidance on this issue.



July 2024: Coordinated Career Pathway Services

The Department released a correspondence to regional centers updating the guidance regarding coordinated career pathway services to all eligible individuals as described in the March 25, 2024, including Self-Determination Program Participants. Regional Centers shall fund CCP outside of the SDP participant's individual budget.
